











Google Workspace for Education Plus Third-Party App Privacy Policy Links

Romeo Community Schools licenses Google Workspace for Education Plus in its learning environment to facilitate access to Google apps and services for all students. Every student has a Google account, and a personal learning device, and begins using the account and device in Kindergarten, continuing through their years in school to graduation. In addition to the educational apps provided by Google, many third parties also create apps used by students while they are signed in to their Google accounts. These third-party apps require configuration with a setting to govern access to the district's Google data (Trusted, Limited, or Blocked) for students under age 18.

The screenshot to the left is a partial list of the apps used by students under 18 in the district. Verified apps have been reviewed by Google to ensure compliance with certain security and privacy requirements. Note that many well-known apps might not be verified in this way. As seen in the example, most apps have Google verified status, but an app that is widely used, Kahoot!, does not have a verified status. In all cases in this screenshot, and in the list below, each app has been configured as Trusted or Limited to allow use by teachers, parents, and students under 18.

The list on the following pages contain links to each app's homepage and Privacy Policy. The privacy policies explain what data the app requests and collects from Google, and what the app does and doesn't do with the data collected.
